#### **Pool/Tennis Maintenance**

This year, the pool shed and cabana will be painted, and the tennis courts power washed to improve traction. Additional grass will be seeded around the poolyard walkway. And the Board is working to provide additional shade at the south end of the large pool.

#### **Pool Opening & Lock Combination**

The pool will be open for the season **beginning Saturday May 28th and closing Monday September 5th**. Tennis nets are already up! And the pool and tennis court **lock combinations have been changed to** *[REDACTED]*. Please manage your family's knowledge of this combination carefully in an effort to mitigate vandalism. Last season, members of the Board observed after-hours use by nonresidents with knowledge of the combination. Please be sure to provide an email address to support mid-season combination changes should this become necessary. (See above.)

### **Pool Hours & Attendants**

While the pool is open from dawn to dusk, pool attendants will be present daily for high-use hours. PLEASE note that our pool attendants are paid to lock and unlock the pool area, ensure the pool area remains safe and clean, check for ID cards, and are available to call for help in the event of an emergency. They are doing these things per our community's agreed-upon rules for the pool facility (see below); please help ensure that members of your household and guests treat them accordingly. And please remember: The pool attendants are *not* lifeguards: Residents and their guests swim at their own risk at all times! Their daily hours will be: 1:00-7:00pm.

#### **Pool Rules**

A complete copy of recreation area policies is available at the pool house. For your convenience and safety, please review the pool policies following.

#### **Recreation Area Use and Hours:**

• Use of the pool and tennis courts is reserved for CHA residents and their accompanied guests. Members and guests use the facilities at their own risk.

 $\circ$  The tennis courts are open from dawn to dusk. Please restrict playing time to one hour if others are waiting.

• The pool is open from dawn to dusk for residents over 18 and minors accompanied by an adult 18 or older. Entry during hours without a pool attendant is by coded lock. From 1:00-7:00pm daily, an attendant is present, and children age 12 and over may be at the pool unaccompanied. The attendant is not a lifeguard; everyone swims at their own risk.

• When an attendant is on duty, pool and tennis court entry will be by CHA identification card. A \$5.00 fee will be charged for replacement of lost cards (one free is allowed per summer; more than one is a cost to the resident).

• Residents' children age 12 and older may bring one guest aged 12+ per visit when swimming without parent/guardians present. Additional guests must be accompanied by an adult homeowner or renter.

#### Safety:

• The attendant has complete authority in the matter of safety and discipline in the recreation area. Tennis courts are for tennis and pickleball only; rollerblading, skateboarding, cycling and scootering are prohibited.

• An adult in the pool enclosure must accompany children under 12.

- The shallow pool is for children less than six years old, or at the attendant's discretion.
- There is to be no horseplay, running, pushing, or diving in either pool.

• The last person(s) to leave the pool / tennis area must lock the gates.

#### **Miscellaneous:**

- No smoking or vaping at the Rec Area.
- No glass is allowed in the recreation area; no food, gum or pets inside the pool enclosure.
- No disposable diapers are allowed in either pool; the fibers from these diapers can clog the pool filters.
- Please keep all gates closed and locked when neither a resident nor an attendant is present.
